We are looking for a highly organized, flexible, and driven **Emergency Programs Officer (EPO)** to be an integral part of our dynamic operations team.

# The Opportunity

The Emergency Programs Officer is a critical, multi-faceted role responsible for the day-to-day operations that keep our aid flowing and our teams ready to deploy. You will be involved in everything from sourcing essential supplies and coordinating volunteer events to drafting funding proposals and, for those who choose, deploying to disaster zones as part of our **Rapid Response Team**.

This position is a **1-year contract** with a strong intention to convert to a permanent role.

**Note on Deployment:** International deployment is a key component of this role, typically **2-3 times per year** for 2-3 weeks at a time. However, candidates who are interested but prefer **not** to deploy internationally are still strongly encouraged to apply, as we may be able to offer a position with modified, non-deployable responsibilities.

## **Key Responsibilities**

The EPO role is split between office-based tasks (approx. **80%**) and hands-on warehouse and field tasks (approx. **20%**).

### 1. Program Logistics & Procurement

- **Source and Procure** all goods and services used in our Emergency Kits and field operations (e.g., aid items, air travel, transportation).
- Conduct comprehensive supplier analysis and present suggestions to management.
- Manage the end-to-end logistics process, including facilitating the ordering and delivery of aid supplies, arranging transport overseas, and completing all necessary shipping paperwork.
- Perform hands-on work in the warehouse to organize, build, and prepare aid for shipment.

## 2. Volunteer Management & Outreach

- **Plan and coordinate aid packing events** and corporate volunteer engagement initiatives.
- Lead volunteer recruitment, communications, and training efforts.
- Contribute to **donor relations** and public outreach by preparing press releases and assisting marketing team with social media/website content.

#### 3. Reporting

- Prepare compelling **funding proposals**, **program reports**, **and briefing notes** for donors and partners.
- Track and manage essential program data for use in all external and internal reporting.

#### 4. Rapid Response Deployment (Optional/As required)

- Travel to disaster zones as a member of the Rapid Response Team, adhering to all security and operational protocols.
- Coordinate on-the-ground field operations, liaising with partner agencies and attending cluster meetings.
- Provide clear and timely communication to HQ, including managing field volunteers and preparing daily situation and financial reports.

## **Qualifications & Experience**

#### **Must-Haves**

- College Diploma or Bachelor's Degree in International Development,
   Humanitarian Assistance, Emergency Management, or a related field.
- Excellent **English writing and communication skills**—ability to draft professional reports and proposals is essential.
- Proficiency with Microsoft Office and Google Workspace.
- Eligible to work in Canada.
- **Valid Passport and current vaccinations** required for international travel (for deployment stream).
- Ability to **lift up to 15 kg** and perform physical tasks common in a warehouse and field environment (carrying, reaching, standing for long periods).

### Nice-to-Haves (Assets)

- Previous related work experience, especially in a humanitarian or logistics context.
- Knowledge of proposal writing, donor relations, and/or customer service.
- Passion for staying informed on current events and global affairs.

The successful candidate will be:

- **Flexible and adaptable**, with a willingness to work on a variety of diverse projects.
- **Efficient under pressure**, thriving in a fast-paced, ever-changing work environment and able to meet tight deadlines.
